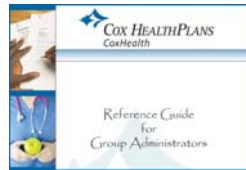

New Drug Limitations List: Cox HealthPlans and Catalyst Rx have released a new way to easily locate medications that may require additional information prior to the first fill. The Drug Limitations List is now available for your employees and their families.

Specialty Pharmacy change: Effective 10/1/10 Cox HealthPlans will be moving the Specialty Medication coverage through Catalyst Rx from Walgreens/MedMark to LDI Integrated Services/Specialty Pharmacy. LDI is a licensed pharmacy who employs both pharmacist and support staff to coordinate the care for our members. We anticipate this transition will have a positive impact on claims costs for our clients.

A letter will be mailed from Cox HealthPlans to those members currently taking a Specialty Medication (~120 members). Members will not be asked to obtain new prescriptions or prior authorizations from their doctor, but will be contacted by an LDI representative in the next few weeks to help assure a smooth transition.
